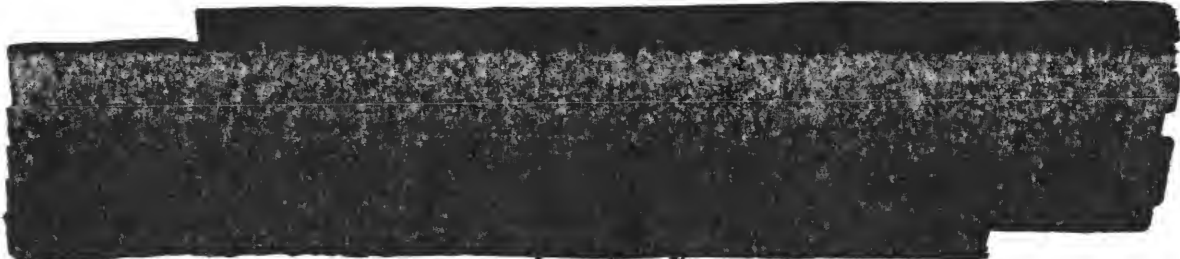

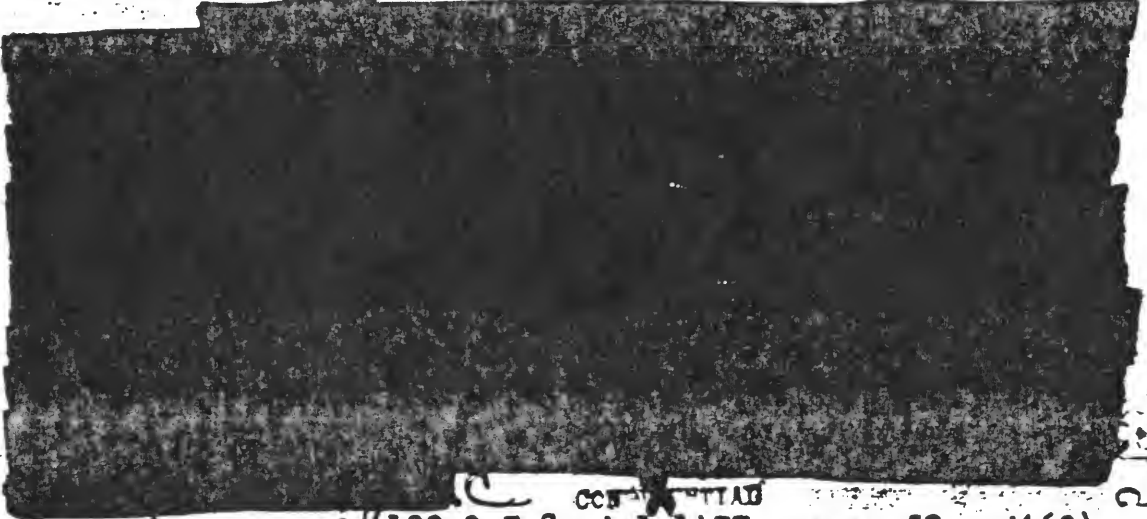

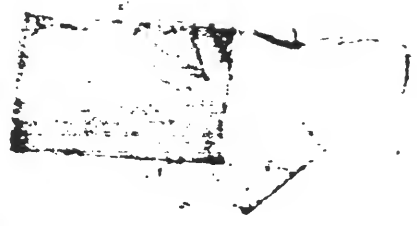

A Negro Woman Speaks for Peace

One of the delegates to the Inter-American Peace Congress in Uruguay tells how they met under extreme difficulties put in their way due to pressure from the U. S. State Department. A first-hand report on what she and other American delegates did for world peace.

By LORRAINE HANSBERRY

(The following excerpts are from a speech delivered by Miss Hansberry, member of the American delegation to the Inter-American Peace Congress, at a "Report Back Rally" held on April 17 in New York. The Congress, originally scheduled to be held in Buenos Aires, and banned by the Chilean government under pressure from the U. S. State Department, was finally held in Montevideo under great difficulties and the direct attack of the government of Uruguay.)

THERE IS SO MUCH I would like to tell, to describe and share with you, who are the peace fighters of our nation—but because there isn't time I shall speak rather of the things I learned—we learned in Montevideo.

We learned something about fraternity, something about courage, something about organization, and we learned a great deal about determination. For this is why the Congress was held—because of the determination of the representatives of the people. This is the great lesson for peoples everywhere, that out of the determination of these 200 or more people who managed to get to the Congress in spite of everything the enemies of peace could hurl at them—passport denial, visa denial, police intimidation, press attacks—the Congress for peace was held. Because the determined peoples of the Americas have said: there must be peace.

HONORED BY PEACE FIGHTERS

The morning after I arrived in Montevideo I went to the meeting of the women. I walked in and someone gave me a seat. The meeting was being addressed by a former woman deputy of the Uruguayan Parliament. Soon this grand woman of peace finished her remarks and someone from the floor stood up and said something I did not understand and suddenly there was applause, and someone told me I had been elected one of the three women to sit on the platform. This was a great honor. There a translator was selected and I stood up to give my report—but a policeman came in and everyone began chatting as though the meeting was a test.

When the policeman left I went on with my report and when I had finished a beautiful

woman of Brazil, came out with a bouquet of sweet red carnations which she flled my arms with. Then she embraced me and made a speech which pledged the solidarity of the women of Brazil, which has a good five million more Negroes than we have in the United States! And I was very moved—of all the women in that room, the real heroines of the peace movement—in America—women who had been in jail, who had known the worst kind of terror—had selected me, the lone representative of Negro womanhood from the United States, indeed, representative of all North American women, to honor—me, who in our own hemisphere, I am ashamed to say, have done the least.

Before I could thank them for this, a young Uruguayan woman stood before me with a little Uruguayan doll in her hand and with tears in her eyes she told me that the people of Uruguay are deeply unhappy and angry because for the first time there is racial discrimination in their country. You should know that one of the uglinesses of the U. S. interests in Uruguay is the presence of a sound truck which has gone through the streets of Montevideo preaching anti-Semitism and race hatred. And there are now hotels in Montevideo where a Negro guest must not stay.

I will never forget the street meeting in the great plaza when the representatives of the nations took their places on a huge platform and each rose to bring

greetings of peace to the peoples of Uruguay who stood under the stars, listening, cheering, shouting over and over again: "Paz Si—Guerra No" (Peace Yes, War No).

I will never forget how my voice choked up a little as I stood to present the U. S. delegation's gift to the Uruguayan host peace committee, and said: "People of Uruguay, in my hand I hold a message from a man whose name is my country—is synonymous with the word peace—and from everywhere it rang out, Viva Robson! Viva Paul Robeson!"

I told them what the little piece of tape recording said, that peace would be won through the struggles of people like themselves, that peace would conquer war, and that, yes, this message was from our beloved Paul Robeson and they cheered again. I will never forget that.

YOUTH MARCHES FOR PEACE

Nor will I forget how when this meeting was over a young man came up to me and said the Jewish Youth of Uruguay had invited all the youth delegates to attend a party at the Jewish Educational Center and that I must come for it was right that our two peoples should celebrate the work of peace together and so I went. The youth were waiting. It was very dark and late. We began to walk. I shall never know where so many young people came from and of course there were police along the streets with their long swords at their sides and their arms crossed and their faces drawn into those long sober expressions peculiar to police all over the world—and these young people linked my arms with theirs and we began to walk four abreast through the streets of Montevideo.

We felt pretty good marching through the city like that. We had had our big meeting right between the U. S. Embassy and a huge C. E. sign—we had gotten into the country and we had met for peace. . . . We had something to sing about and we sang—the song of free democratic youth all over the world. I walked with my arms linked in my brothers' arms, a young man of Argentina on my right and a young man of Brazil on the left. It was as if in the strength of their arms I could feel the promise of the future. We sang with all our hearts in Spanish and Portu-

Uruguayans peace sentiment greeted the delegates to Montevideo. On walls, pavement, houses, everywhere that signs could be posted or painted, peace was the word. Here on the wall of a building is painted the demand: "Peace, Yes! War, No!"

guese and English and Jewish. We are the youth, and the world acclaims our song."

We sang for those who were not there, for the heroic youth of Peru and Guatemala and Bolivia and Panama and Ecuador and Canada and Puerto Rico. And, though we never called their names, we sang with all our hearts—in fraternity—for the youth of great Peoples' China and—yes, for the youth of the great Soviet Union, for you are the generation who are asked to fight them and who say rather that we, the youth of the Americas, want only peace and friendship with them and their people.

OUR RESPONSIBILITY AND TASK

But make no mistake, there was a question that I was asked again and again in Montevideo, and it is this:

What are the people of the United States, the great working people of this country, doing to stop the Korean war?

Each person who asked this was speaking for the decent people everywhere in the world. A young woman of Argentina who was a member of the Women's International Commission which went to Korea, asked: "What is happening to the young men in the United States

to make them such monsters?"

This is the bitter part, it is difficult to think that these "monsters" the people of the world are talking about are our own sons and brothers. Today, in 1952, the peoples of the world ask of the people of the United States what we asked of the German people a few years ago.

I have heard atrocities described which with all my heart I wish were not the work of the men of our land. But history will be objective and it will indict the guilty. And if we do not take up our burden our own hands will be the guilty ones. We must drive home to the American people what is going on in their name.

The peoples of the Americas have accepted their task—8,000,000 signatures to the petition for a five-power peace pact are testimony to that. We have no right as a people to stand before the nations of the world with the guilty of our government on our hands. Rather together with them, Negro and white, let us take the great call of the peoples to heed and go up and down our United States getting the names of our people signed to the petition for a five-power peace pact.

Long live the peoples! Long live peace!

The subject also indicated at the time of her registration that she attended Engelwood High School, Chicago, Ill. from February 1944 until the time she graduated on January 28, 1948.

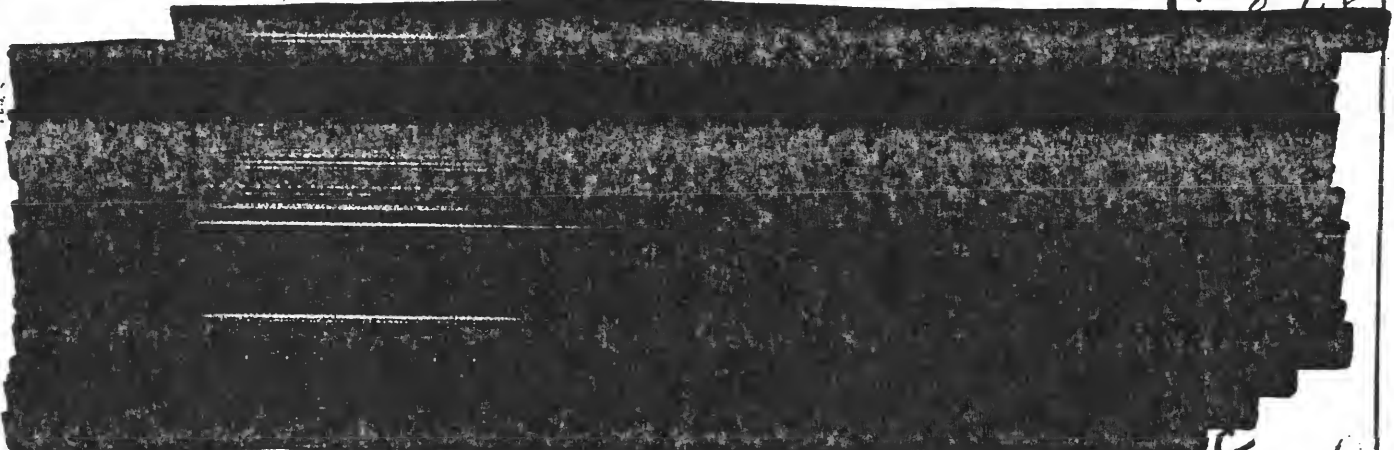

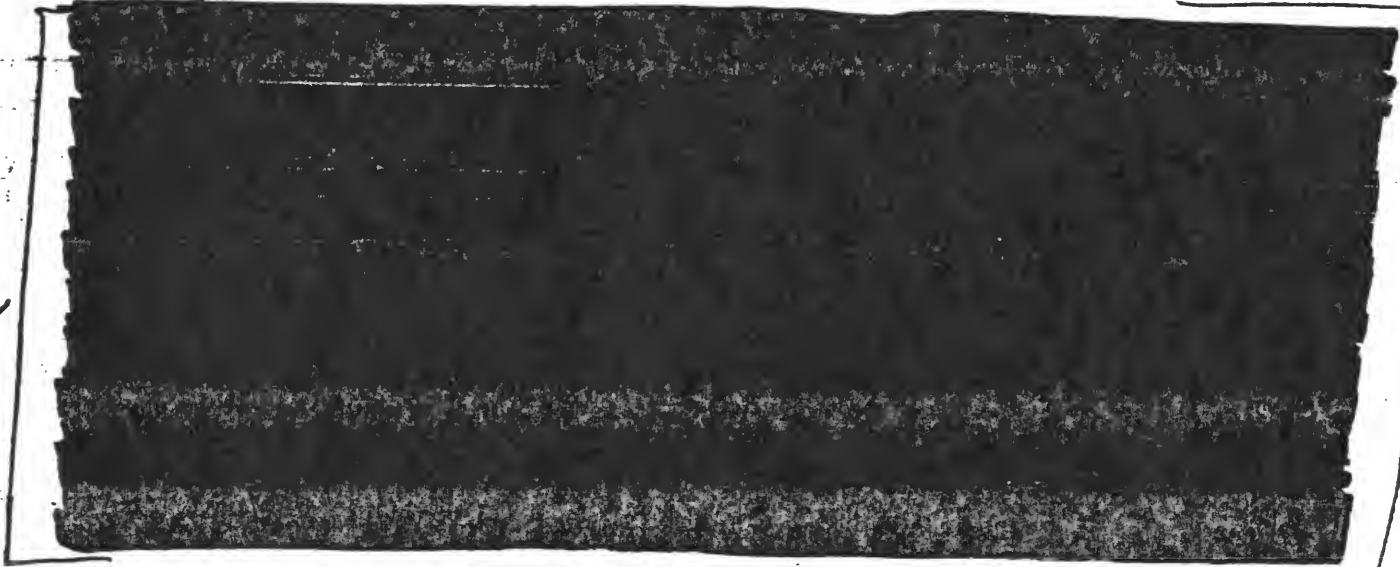

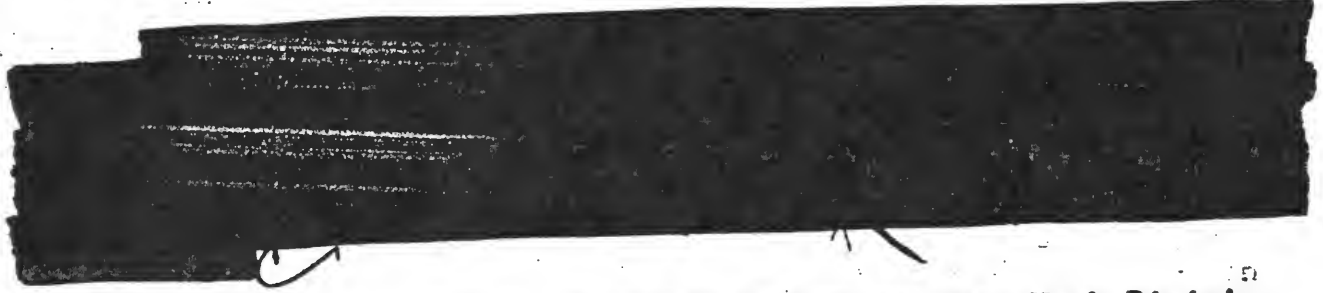
