It is to be noted that it has been previously set forth in this report that in attendance at this rally were JOHN DARR, JR., and MARY RUSSAK, of the American Peace Crusade; MOE FISHMAN, of the Veterans of the Abraham Lincoln Brigade; and WILLIAM PATTERSON, of the Civil Rights Congress. All of these organizations have been designated by the Attorney General of the United States pursuant to Executive Order 10450.

It is also to be noted that participants in this rally, as previously set forth, included ELMER BENDINER, FLORENTINO L'UIS, PAUL ROBESON, ROBERT MORSS LOVETT, and LORRAINE HANSBERRY, whose Communist Party affiliations have previously been set forth in this report.

On March 15, 1954, an article appeared in the "Daily Worker," page 3, column 3, entitled "Overflow Rally Here Demands No Intervention in Guatemala." The article states "They came over 1000 strong, jamming every inch of old Manhattan Plaza Friday night to raise the cry 'no intervention in Guatemala!' Speaker after speaker hammered home the point, 'Don't let Guatemala become another Spain!' --and the capacity crowd roared its enthusiastic approval.

"This was a sober crowd grimly aware that the U.S. 'anti-Communist' resolution at Caracas was simply the hoary

ANGOLA

The March, 1963 issue of Liberator in part reflects on page 2 that "the Liberation Committee for Africa's Negro History Week program took place on Sunday, February 10, before 350 people at St. Luke's Protestant Episcopal Church at Convent Avenue and 141st Street. Featured speakers were Carlos Goncalves, official representative of the Angolan National Front, Oyil Chakamoi of Uganda and Lorraine Hansberry, author and critic. Reverend David Johnson opened the meeting with one moment's silent prayer for fallen African freedom fighters, especially Patrice Lumumba.

"Mr. Goncalves painted an eloquent picture of the impossible conditions existing today in Angola under Portuguese oppression. He also talked of the need of the Angolan people for both physical and moral help and inspiration, particularly from their brothers of African descent in the United States.

"Mr. Chakamoi talked of the real feeling of kinship which all African students have for Afro-Americans; of the community interest existing. He also described the great financial difficulty confronting African students here on United States government or foundation grants, especially during the summer months.

"Miss Hansberry's most moving and eloquent address thanked the young Africans for their taking real, positive and inspiring steps into the twentieth century.

"She spoke of the need for changing the present and insufferable idea of the 'exceptional Negro'. Fair and equal treatment for Ralph Bunche, Jackie Robinson and Harry Belafonte is not nearly enough. Tea parties at the White House for the few will not make up for 300 years of wrong to the many. The boat must be rocked for the good of all."

OYIL CHAKAMOI is listed later herein as being associated with PASOA.

CARLOS GONCALVES is the Director of the Angola Information Office, 10 East 16th Street, New York City. He is a Registered Agent representing "The Government of the Republic of Angola in Exile".

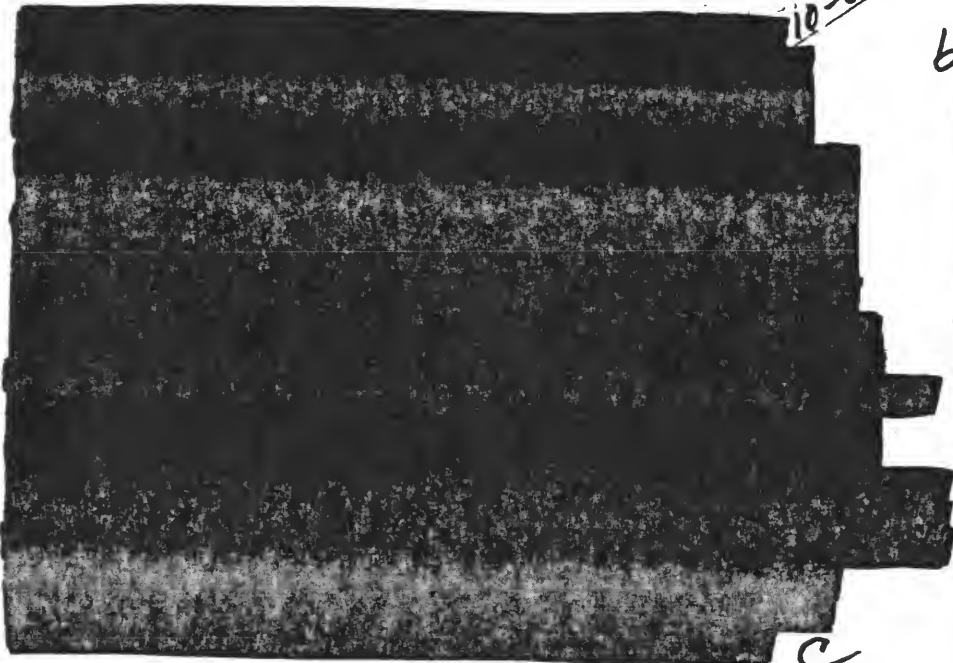

An article in "The Worker" for January 6, 1952, Section I, Page 8, Column 2, announced that a proposal to establish a Frederick Douglass Educational Center in Harlem would be discussed at a conference of trade union and people's leaders on January 12, 1952 at Thoresa Hotel in Harlem.

The article said the call for the conference, signed by W. ALPHEAUS HUNTON and ROSALIE BERRY for a group of twenty-eight sponsors, proposed that the new school be launched as a Marxist educational and cultural center based on the needs of the negro, West Indian, and Puerto Rican workers of the Harlem community.

Sponsors of the conference, in addition to HUNTON and BERRY, the article said, included HERBERT APTHEKER, LLOYD BROWN, LOUIS BURNHAM, JESUS COLON, ANGIE B. DICKERSON, PHILIP S. FONER, DAVID GOLDWAY, SHIRLEY GRAHAM, PEARL LAWS, LOUISE T. PATTERSON, WILLIAM L. PATTERSON, PAUL ROBESON, and DOXEY WILKERSON.

Mrs. ROSALIE BERRY was scheduled to be Director of the school, according to the "Amsterdam News", for March 15, 1952, Page 30, Column 2, and among the instructors were to be:

DAVID GOLDWAY, CLAUDIA JONES, LLOYD BROWN, W. ALPHEAUS HUNTON, MERCEDES ARROYO, LORRAINE HANSBERRY, ARMANDO ROMAN, DOXEY A. WILKERSON, BEATRICE GOODLOE, and JOSE SANTIAGO.

On March 17, 1952, the Frederick Douglass Educational Center opened at 124 West 124 Street, Harlem, according to the "Daily Worker" for March 24, 1952, Page 8, Column 4.

Prensa Latina (PL) is a Cuban news agency with headquarters in Havana, Cuba, and branches throughout the world. Prensa Latina, which was organized in Cuba on June 16, 1959, follows in its releases an editorial policy which is anti-United States and pro-Soviet Union.

On April 16, 1962, Prensa Latina filed a statement with the United States Department of Justice conceding that the agency receives the sum of \$125,000 (Cuban) monthly from Radio Difusora Nacional, an agency of or under the supervision of a ministry of the Government of the Republic of Cuba.

On April 18, 1962, Prensa Latina entered a plea of nolo contendere in Federal District Court, Washington, D. C., to a charge of failure to comply with the provisions of the Foreign Agents Registration Act of 1938, as amended, and was fined \$2,000.

Negro's Passport Fight Knocks On JFK's Door

Urge B'nai B'rith Halt Kennedy Honor Unless Newsman Is Cleared

NEW YORK — When the federal government tried and convicted a Negro newsman because he visited Cuba without State Department sanction it started storm winds that are now blasting at the White House door.

This was apparent last week as prominent Americans, including Nobel Prize-winning Dr. Linus Pauling and author James Baldwin, joined a nationwide citizens' committee to protest a "democratic legacy" awarded to President Kennedy by the Anti-Defamation League of B'nai B'rith.

William Worthy, internationally known newsman sentenced to three months in the highly publicized "illegal re-entry" case, told Muhammad Speaks last week that protests from the Negro community prevented him from receiving much stiffer term.

Ruby Dee cause of what he said about Cuba and not for any technical violation of the law, has publicly contrasted the lack of discrimination in Cuba with America's pattern of white supremacy.

He rapped the Kennedy Administration's civil rights record, saying, "The administration has done only what it has been forced to do by the struggles of the Negro. I did nothing more."

KENNEDY, however, has been named by the Anti-Defamation League to receive a "democratic legacy" award

Jan. 31, at a \$100-a-plate banquet at the Sheraton Park hotel, Washington, D.C. It is this award, that Americans, "Negro and white, Jewish and Christian," are urging B'nai B'rith to withdraw from the President.

Civic leaders are calling for a demonstration outside the hotel from which speech will be CBS, and have simultaneous the President's televised over appealed for rain-or-shine demonstration's outside AntiDefamation League and B'nai B'rith offices across the country on Tuesday afternoon, January 15.

The statement by the leaders declared:

Among other signers of the statement were actor Ossie Davis of "Purlie Victorious;" actress Ruby Dee; Lorraine Hansberry, author of the play, "Raisin in The Sun," and Conrad J. Yynn, civil rights attorney.

ANTI-DEFAMATION League offices to be picketed January 15, include those in Los Angeles, San Francisco, Seattle, Chicago, Detroit, Cleveland and Philadelphia. Other picket committees are being formed in additional cities.

Worthy, who has just completed a coast-to-coast lecture tour, is appealing his three-month sentence to the Fifth U.S. Court of Appeals. His sentence is stayed, pending the appeals.

Kennedy award protested

A CALL FOR nation-wide demonstrations this month by "liberty-loving Americans, colored and white, Jewish and Christian" to protest a "democratic legacy" award to President Kennedy was issued in New York Jan. 6 by a group of prominent citizens. The protest stems from the William Worthy "illegal re-entry" case.

Dr. Linus Pauling, Nobel laureate in chemistry, and author James Baldwin are among signers of a statement urging the Anti-Defamation League of B'nai B'rith to withdraw its award from the President "unless the Department of Justice drops the scandalous harassment of Mr. Worthy." Worthy, U.S.-born correspondent for the Baltimore Afro-American, was convicted of re-entering the U.S. without a passport after a trip to Havana. He is appealing a three-month sentence.

The Anti-Defamation League plans to

confer the award on Kennedy at a banquet Jan. 31 at the Sheraton-Park Hotel in Washington. The protest group called for a demonstration outside the hotel at 5:30 p.m. Jan. 31, and simultaneous demonstrations Jan. 15 outside ADL and B'nai B'rith offices across the country. In New York, the Harlem Anti-Colonial Committee will demonstrate outside the ADL office at 515 Madison Ave. between noon and 2 p.m. Jan. 15.

The statement of protest declared, "The Worthy case has become a classic in man's endless struggle to write freely, to speak freely, to travel freely and to know the truth about the world around him."

Signers included Ossie Davis, actor; Ruby Dee, actress; Dorothy Day, editor of the Catholic Worker; David Dellinger, editor of Liberation magazine; Lorraine Hansberry, playwright; Conrad J. Lynn, civil rights attorney, and Mrs. Pauling.

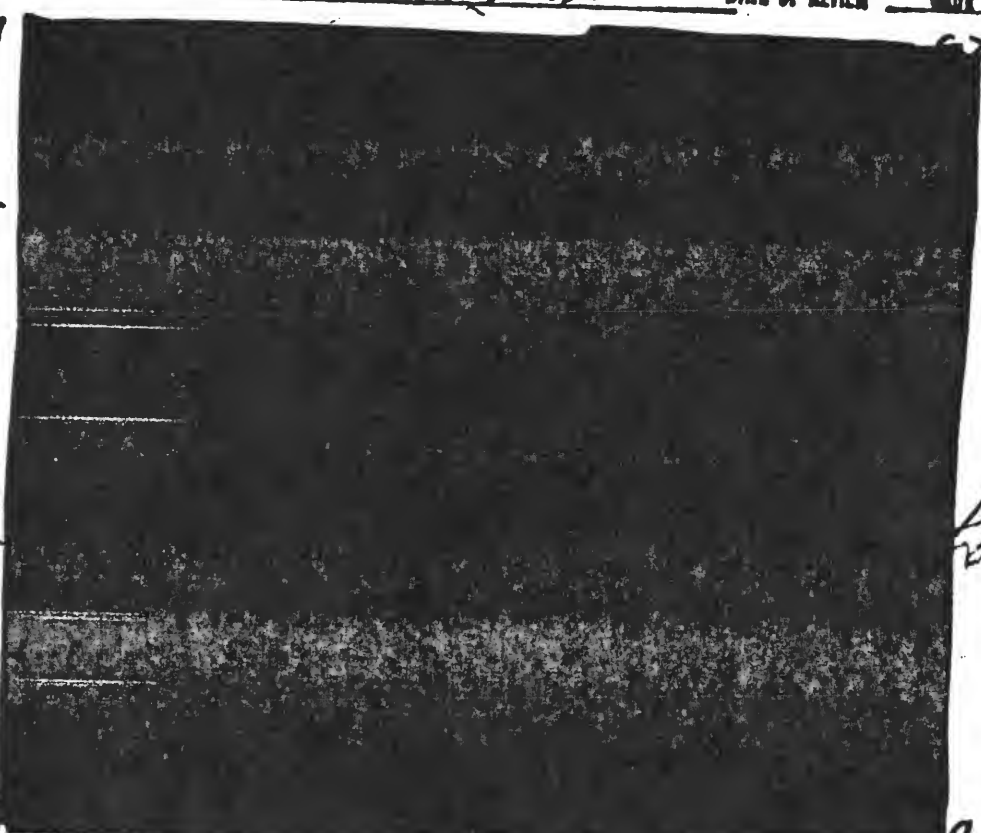

Frederick Douglass Educational Center Established in Harlem

An article in "The Worker" for January 6, 1952, Section I, Page 8, Column 2, announced that a proposal to establish a Frederick Douglass Educational Center in Harlem would be discussed at a conference of trade union and people's leaders on January 12, 1952 at Theresa Hotel in Harlem.

The article said that the call for the conference, signed by W. ALPHEAUS HUNTON and ROSALIE BERRY for a group of twenty eight sponsors, proposed that the new school be launched as a Marxist educational and cultural center based on the needs of the negro, West Indian, and Puerto Rican workers of the Harlem community.

Sponsors of the conference, in addition to HUNTON and BERRY, the article said, included: HERBERT APTHEKER, LLOYD BROWN, LOUIS BURNHAM, JESUS COLON, ANGIE B. DICKERSON, PHILIP S. FONER, DAVID GOLDWAY, SHIRLEY GRAHAM, PEARL LAWS, LOUISE T. PATTERSON, WILLIAM L. PATTERSON, PAUL ROBESON, and DOXEY WILKERSON.

Mrs. ROSALIE BERRY was scheduled to be Director of the school, according to the "Amsterdam News," for March 15, 1952, Page 30, Column 2, and among the instructors were to be:

DAVID GOLDWAY, CLAUDIA JONES, LLOYD BROWN, W. ALPHEAUS HUNTON, MERCEDES ARROYO, LORRAINE HANSBERRY, ARMANDO ROMAN, DOXEY A. WILKERSON, BEATRICE GOODLOE, and JOSE SANTIAGO.

On March 17, 1952, the Frederick Douglass Educational Center opened at 124 West 124th Street, Harlem, according to the "Daily Worker" for March 24, 1952, Page 8, Column 4.

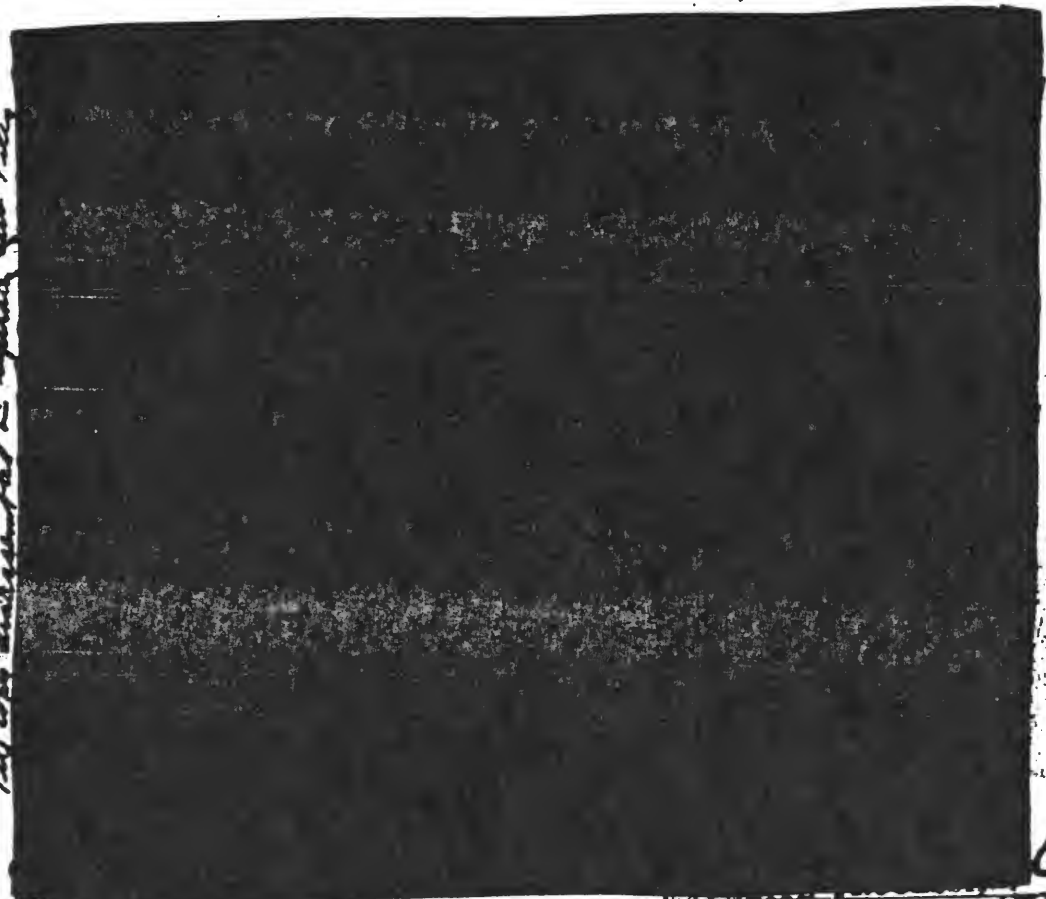

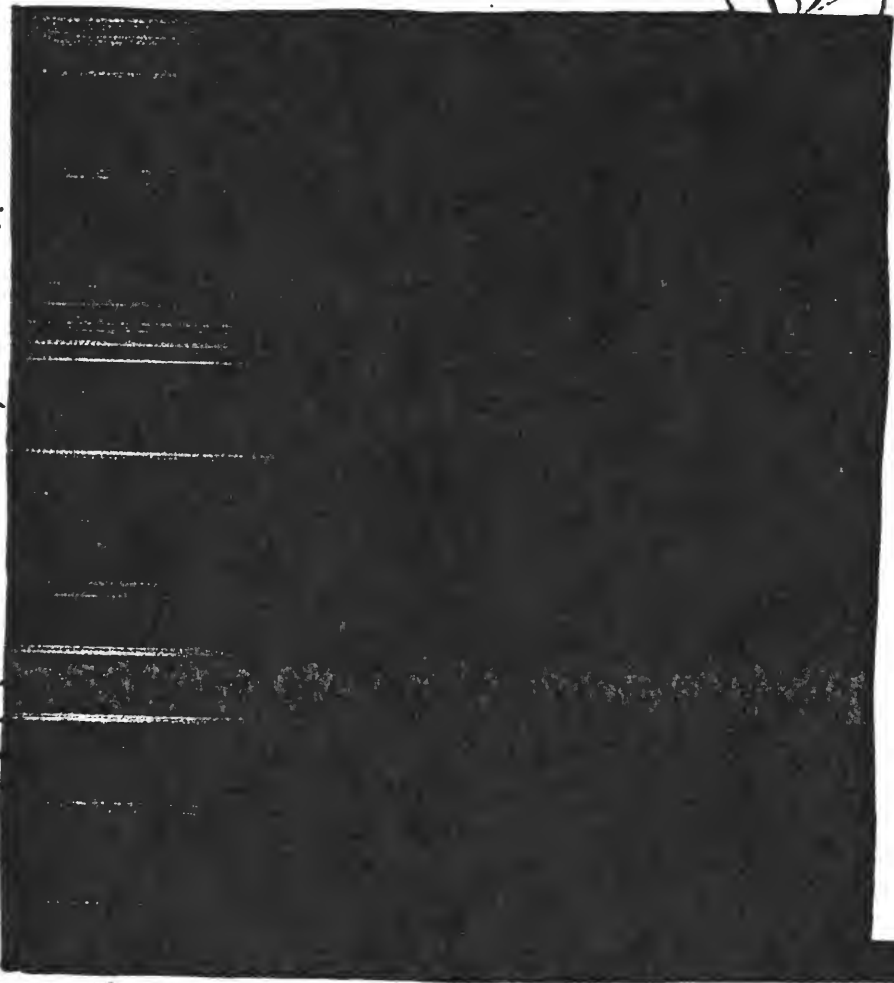

Chicagoan Tells How People Of Latin America Fight War

By PAT RICHARDS

CHICAGO.—The story of Chicago's Estelle Schwartz and her journey with four other U. S. representatives to the recent inter-continental American Peace Conference held "illegally" in Montevideo, Uruguay, is a thriller beside which the fiction of high-paid adventure writers pales to insignificance.

It is a story of heroism and villainy, of courage and oppression, of suffering and hope. Its heroes and heroines are the millions of those other Americans—south of our border—whose lives had been shrouded for Estelle, as for most other U. S. Americans, in a curtain of government censorship.

Miss Schwartz, a native Chicagoan, mother of a three-year-old son and a leader of the youth peace movement of this city, told us the story the other day, as she has told it tirelessly to fascinated audiences here since her return from South America one month ago.

"FROM the moment of our departure by plane from Miami," she said, "the ugly truth about U. S. domination of this whole hemisphere began to emerge for us—in the words of cautious fellow passengers, in the attitudes of native South Americans at the many airports where our plane stopped."

The first mention of this exploitation came from the lips of a young passenger sitting next to her on the plane, an Argentinian employed by an American airlines company. He talked about his admiration for Argentinian dictator Peron—and then remarked:

"You Americans do not permit any other American nation to operate intercontinental airplanes."

Later, on her journey, the young Chicagoan discovered that the hatred of U. S. domination is so widespread through Argentina that to win votes, fascist Peron had made his chief slogan: "Get

rid of the U. S. imperialists!" Many of those who voted for him were now asking: "Why haven't the U. S. companies been kicked out? Peron, bed!"

TWO things were the same at every airport where they landed, across the thousands of miles they traveled.

"What we saw first, everywhere, were U. S. officers, many of them, often accompanied by families and luggage," related Miss Schwartz.

"Then we saw the native people, standing apart, silent, poorly dressed, with worried and hostile expressions.

"Our little group of delegates got the same cold reception. Whenever we managed to explain our mission, the hostility melted. We were greeted warmly, and the questions tumbled out eagerly from everyone."

ON ORDERS of the U. S. government, the peace conference, originally scheduled for Rio de Janeiro, was refused a meeting place by Brazilian officials. Shifted to Chile, it was stopped there. Moved by its organizers to Montevideo, the Uruguayan government invoked an old law to stop it there. The law banned any meetings "in which a friendly foreign power is attacked."

"It is a lie that the conference attacked the people of the United States," declared Estelle Schwartz. "The people of Latin and South America know how great a difference exists between the millions in our country who want peace, and the few who plot wars and influence our government."

"They had only words of friendship for the people of the United States. But they had contempt for the U. S. profiteers who have robbed them of their own resources for decades, and who now threaten to plunder Asia as well."

THE conference was held in

Montevideo, in spite of the ban. It met secretly in private homes—where the warning of approaching police squads once converted the meeting into a gay "party" with music and dancing. Delegates from some 12 countries got through—countless others were held up, by Argentina and other U.S.-run countries. Numerous U. S. delegates, like Paul Robeson, were denied passports.

But the desire of Uruguayans for peace could not be banned by their government—nor suppressed by U. S. officials. While the conference proceeded in secret, more than a quarter of a million people of Montevideo demonstrated in a huge outdoor rally in the main square, chanting over and over: "Paz, Si, Guerra, No!"—"Peace, Yes, War, No!"

U. S. delegates, and those from other nations, addressed the rally bringing the message that their

people too demanded peace. Corina Hansberry, young Negro woman from New York City, presented Paul Robeson's message to the cheering throng. Miss Schwartz's eyes shone as she described it.

"The men, women and children embraced Miss Hansberry with tears and kisses, paying tribute through her to Robeson and the Negro people of the United States, with whom they feel brothers in U. S. imperialist oppression."

AT the conference itself, the other delegates made it clear to those from the United States that their people must have peace—to win national freedom from U. S. control.

In the name of "Point 4," and "defense against Communist aggression," they explained, just U. S. military bases and military highways have been built throughout South America by the U. S. government. These military forces,

expanding daily, stand guard over the U. S.-owned mines, factories and fields, in which whole families live at starvation wages.

"The people of South America see no Russian soldiers on their land. The bosses who exploit them are Americans—not Soviet Russian—nor Chinese. Neither the workers, nor the middle class, nor even the army men of the South American countries regard Communism as the threat. They want freedom from the United States!"

ACTIVE in the work of the peace conference was Brazilian Brigadier General Sao Benevides, selected to the Secretariat at the close of its sessions. He was there to work for world peace in the interest of Brazil's national independence. He represented a prominent Military Club of Brazil.

What did the delegates mean when they spoke of national liberation? Miss Schwartz listed their aims, as they described them:

Free public schools. Today there is not one free public school anywhere in South America, they reported. Even government-sponsored schools charge fees—and only the children of the rich can attend.

An end to child labor. South American children labor in the U.S.-owned mines of Anaconda Copper, in the textile factories owned by U. S. interests.

Decent housing, adequate food and medical care. The workers of Argentina, Brazil, Chile, Uruguay, Paraguay, many of them visited their homes by the U. S. dele-

gates, live in tar-paper shacks, without plumbing or flooring. Largest livestock breeders in the world, Argentinians labor for Armour's and Swift & Co., and can afford no meat. Their TB rate matches the highest in the world—leprosy in Paraguay dwarfs the figures on that practically extinct disease in other parts of the world.

"THEY are confident they can win these goals if U. S. war plans are checked," the Chicago delegate said. "They want people's governments, which will trade with the United States and all other nations in the commodities of peace, machinery, food, clothing and refrigerators.

Throughout South America, strong people's movements for national liberation are organizing the people to establish their own governments—movements in which the Communists play an honored role. "They are held in check by what amounts to U. S. armies of occupation," Miss Schwartz reported.

To suppress the people's movements, U.S.-manipulated governments have illegalized the Communist Party and the peace movement as well. Yet their delegates proudly reported they had secured over eight million signatures on the appeal for a five-power pact of peace. They vowed at the

conference to "heighten and intensify" their signature campaign, even as they reported how peace leaders have been tortured, jailed, crippled for life, by local police acting on orders of their United States masters in the consulates and embassies throughout the Americas.

"WHAT will U. S. labor do in this fight for peace?" they asked our delegates. "Don't they realize that our low wages are a threat to their own living standards? Our bosses are their bosses, too. When we strike our slogan is: 'More money for bread, no more for war.' That must be the slogan of U. S. workers, too!"

This, and much more, is the thrilling story which Estelle Schwartz tells to all whom she can reach. She said: "I want to speak before many groups. Tell people to leave messages for me at the office of the American Peace Crusade, 166 West Washington St.

"We have a great responsibility to the people of Latin and South America," she adds. "At the Intercontinental Peace Conference in Montevideo they called us to our responsibility—politely, but sharply, they called us to the task of convincing our own government that we will not accept war as the solution to world problems. We must answer that call."
