HANSBERRY, occupation real estate, address 5936 S. Park, Chicago, Ill. since 5/39.

Her transcript on file in the registrar's Office reflects that she matriculated at the Univ. of Wis. 2/9/48 and attended the second semester of 1947-48 school year, the first and second semester of the 1948-49 school year, and the first semester of the 1949-50 school year. On 2/10/50 she was placed on final scholastic probation. The transcript reflects that she was a student in a Bachelor of Arts and Advanced Arts Courses but she did not graduate. 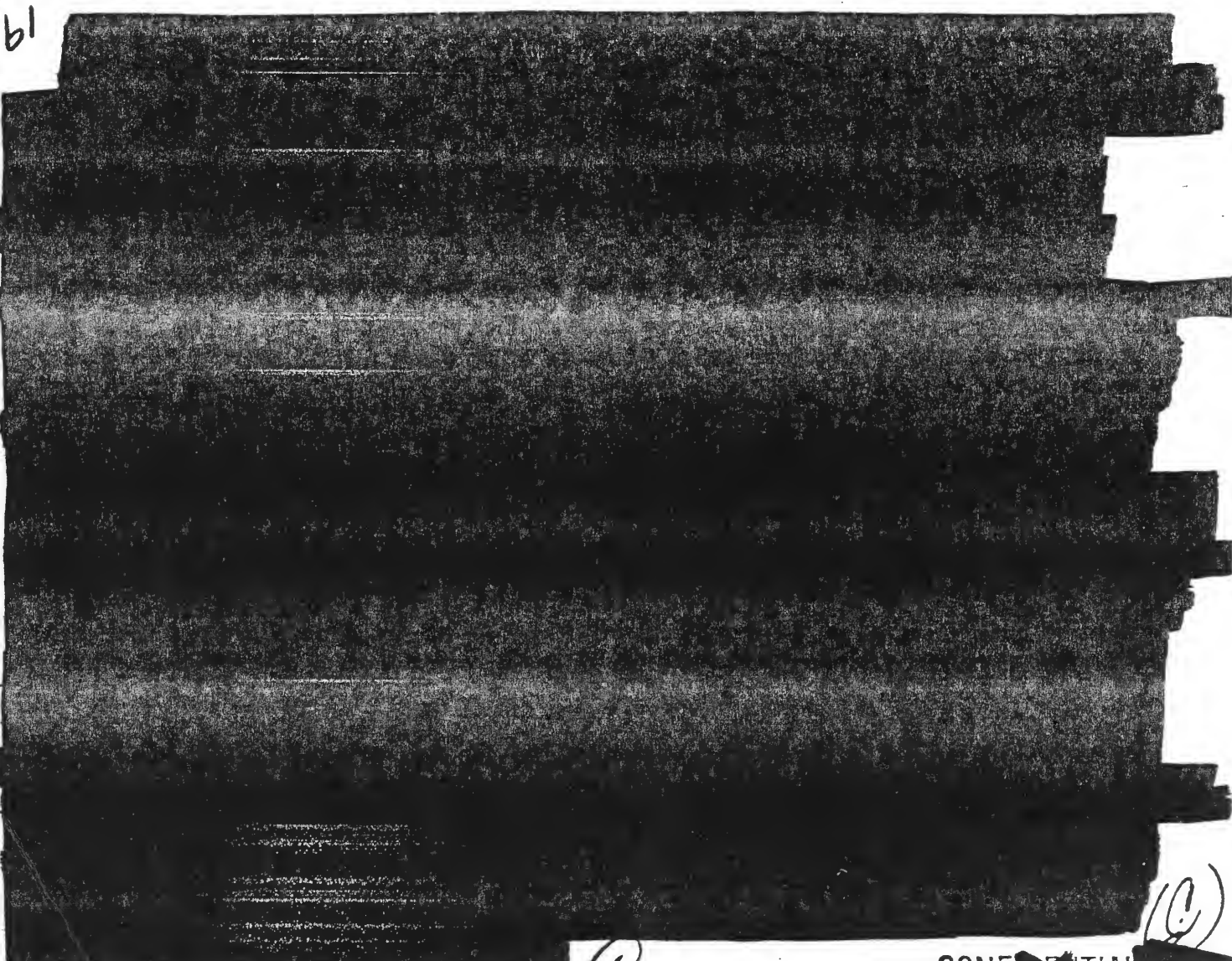


