This individual's file reflects that she was born 5/19/30 in Chicago, Illinois, Negro, resided at 337 Bleacher Street, NYC, in September, 1956, and was employed by People's Artists, Incorporated, 124 West 21st St., NYC, in September, 1956.

It is to be noted that People's Artists, Incorporated, has been cited as a Communist front. (California Committee on Un-American Activities, Report, 1948, page 392).

Further- LORRAINE NEMIROFF was Associate Editor of "Freedom" in 1952, and at an unspecified time wrote articles for the "Daily Worker" under the alias of JOHN HENRY. The Fall 1955 editions of "New Challenge" identified LORRAINE HANSBERRY as the Associate Editor of "New Challenge".


There is a possibility that LORRAINE NEMIROFF might possibly be identical with captioned subject, although nothing has been located in the files of NYC to factually substantiate this observation.

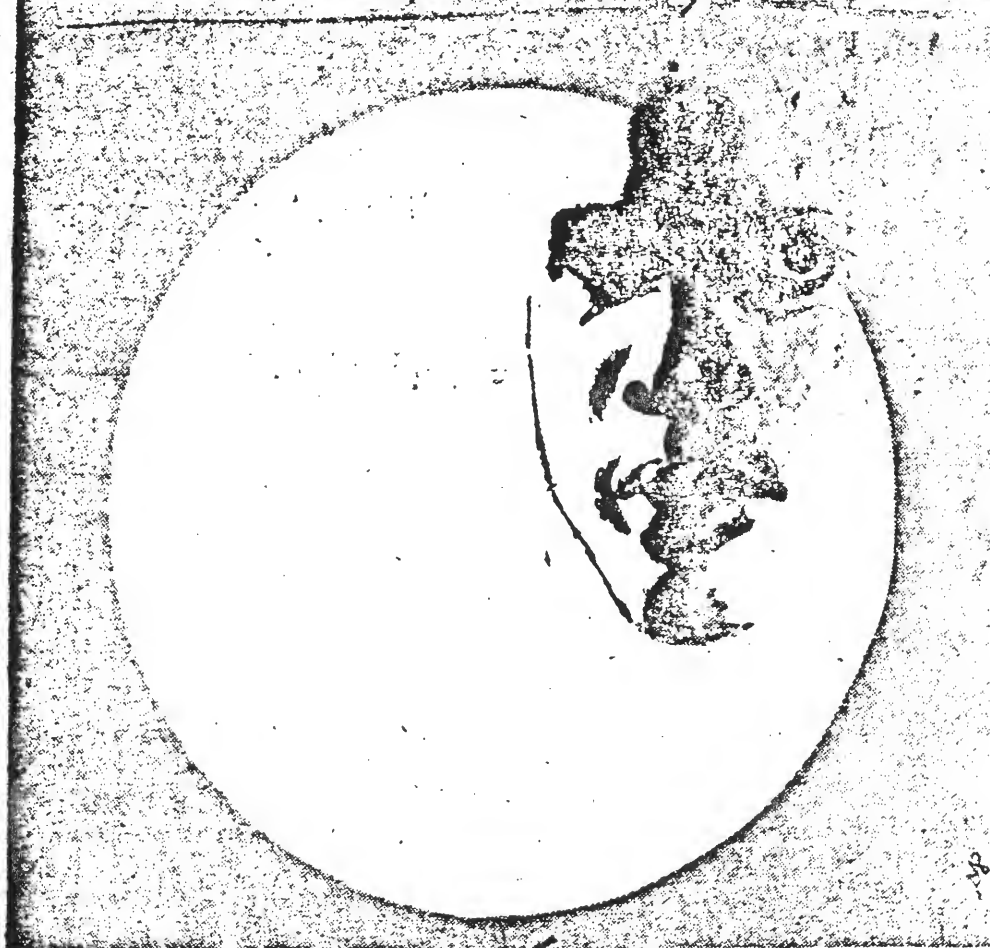

Footlight Fare Old And New

By BARBARA L. WILSON

Two plays by authors new to Philadelphia, two classics, a local premiere and "Redhead's" final stanza at the Shubert comprise this week's theatrical fare. The playwrights making their bows here are Lorraine Hansberry with "A Raisin in the Sun"

at the Walnut tomorrow, and George Panetta, whose comedy "The Poker Game" opens at the Forrest Tuesday evening.

The Erlanger and 43d Street Theater show a decided propen-

cy for early 17th century manuscripts with their respective productions of Shakespeare's "Hamlet," opening tomorrow, and Ben Jonson's "Volpone," due Wednesday night.

SIDNEY POITIER STARS

At the Ogontz Tuesday evening, "Compulsion" will be staged in Philadelphia proper for the first time. Meyer Levin's dramatization of his own best-selling novel had its American debut at Bucks County Playhouse last summer following successful productions in Europe.

All productions have 8 o'clock opening night curtains with the exception of the Old Vic's "Hamlet," which begins at 8:15 P. M. "A Raisin in the Sun" stars Sidney Poitier and features Ruby Dee as his wife, Claudia McNeil as his mother, Diana Sands as his sister and Louis Gossett as her helpful but reticent sweetheart. The cast has been directed by Lloyd Richards.

In the contemporary Chicago setting, Poitier is described as portraying "a perplexed young man whose dreams and ambitions soar beyond reality to the extent that he precipitates a crisis which eventually involves his entire family."

TITLE FROM POEM

The title of Miss Hansberry's play is found in Langston Hughes' poem which reads:

*What happens to a dream deferred
Does it dry up
Like a raisin in the sun?
Or fester like a sore—
And then run?
Does it stink like rotten meat?
Or crust and sugar over—
Like a syrupy sweet?
Maybe it just sags
Like a heavy load.
Or does it explode?*

Miss Hansberry says that her play is "an effort to say a great deal about a large and important part of our contemporary situation. I believe one or two affirmative things are still left to be said about life and people."

Originally interested in painting, the author explains that she began writing plays about six years ago to teach myself how I would read them to my husband (music publisher Robert Nemeroff) and then put them away in a drawer.

PANETTA'S 'POKER GAME'

The first draft of "Raisin" emerged during the eight or nine months between her 26th and 27th birthdays. Last fall she read it to her personal friend Phil Rose and the morning following the reading Rose optioned the script to produce it with David J. Cogan.

For "The Poker Game," George Panetta, who speaks for himself elsewhere in this section, joins forces again with director Ruth Rawson and producer Norman Forman who helped the humorist make a success of his "Comic Strip" last season in New York.

The comedy concerns the cis-

in the Caparuta family precipitated by the daughter-in-law whose faith and principles conflict with her relatives' beliefs. Doretta Morrow, in her first non-musical appearance, plays the outsider, and J. Carrol Naish and Aline MacMahon portray the elder Caparutas whose offspring are depicted by Kay Medford, Cliff Norton, Larry Pennell, Tom Pedi and Dorothy Greener.

NEVILLE AS 'HAMLET'

"Hamlet" is the third play in the Old Vic's current repertoire here. John Neville changes from his comic role of Sir Andrew Aguecheek in "Twelfth Night" to portray the tormented Dane of the Bard's drama.

Depicting the other principles are Barbara Jefford as Ophelia, Oliver Neville as Claudius, Margaret Courtenay as the Queen, Joseph O'Connor as Polonius and John Humphry as Laertes.

Ben Jonson's "Volpone," published in 1606 three years after "Hamlet," is an exposure of human greed, written in scathing terms yet with mocking humor.

Star of the 43d Street production is Richard Easton appearing as Mosca (The Fly), cunning servant of the greedy Volpone, played by Sem Kressen, who delights in making his similarly avaricious friends believe that they will fall heir to his fortune.

DRAMA OF MURDER

"Compulsion," semi-fictionalized account of Chicago's Leopold-Loeb murder in the 1920s, has David Rounds and David Barrett in the leading roles of the teen-age murderers. The 22-member cast, directed by George Lipton, also includes Linda King, Al Medinets, Buck Tartalian, Tim Herbert, Joe Macaulay, Alex Alexander and Jacqueline Michaels.

Madeleine Sherwood, who played sister-woman in Tennessee Williams' "Cat on a Hot Tin Roof" on stage and screen, has been signed to portray Sidney Blackmer's sister-housekeeper in Williams' new drama, "Sweet Bird of Youth," trying out at the Locust Feb. 9.

Also set for the play is Logan Ramsey, a former Philadelphia and an alumnus of Hedgerow.

SUBSCRIPTION OFFERING

The third and fourth weeks, beginning Feb. 23 and March 1, of the local engagement of the new musical, "First Impressions," at the Forrest, will be on the local Theater Guild-American Theater Society subscription series.

John Ireland is set as the villain and Jack Prince, the sheriff, in "Destry Rides Again," Harold Rome and Leonard Gershe musical, costarring Andy Griffith and Dolores Gray. It opens at the Shubert March 9.

There is a rumor circulating that Carol Lawrence, the Maria of "West Side Story," will be contracted to portray the title role in "Gypsy," musical version of Gypsy Rose Lee's autobiography, due at the Shubert April 6. Ethel Merman will star as the mother of the famed stripper.

Family Life Is Theme of Two Plays Bowing Here

THE FAMILY CIRCLE, a subject which has intrigued playwrights from Euripides through Tennessee Williams, is the concern of two young dramatists in two new plays opening on Philadelphia stages this week.

Tomorrow night, at the Walnut, a 27-year-old Negro authoress from Chicago will be introduced to local playgoers with the drama, "A Raisin in the Sun," about a family in her own Windy City. The playwright is Lorraine Hansberry, and her play stars Sidney Poitier, the young actor who recently won such acclaim for his vivid screen performance opposite Tony Curtis in Stanley Kramer's film, "The Defiant Ones."

Tuesday night, at the Forrest, a Manhattan writer takes the big plunge from Off-Broadway to Broadway with his comedy, "The Poker Game," in which he describes his own Italian family in New York. He is George Panetta, whose "Comic Strip" in an Off-Broadway theater brought him to the attention of Broadway producers. Holding top hands in "The Poker Game" are J. Carrol Naish, Doretta Morrow and Aline MacMahon.

The two incoming plays, each to run here two weeks, will join the hold-over musical, "Redhead," in which Gwen Verdon is being applauded by capacity audiences at the Shubert; and the Old Vic Company

at the Erlanger with "Hamlet" and "Twelfth Night" in repertory.

"Redhead" is proving that three weeks are not enough for a good musical to play Philadelphia, there being many more ticket seekers than there are seats available before the show departs January 31.

Our popular British cousins from Waterloo Road in London bring us five performances of "Hamlet," with John Neville in the title role, tomorrow through Thursday, with a Wednesday matinee. Old Vic ends its visit on Friday and Saturday with three repeat performances of "Twelfth Night," including a matinee

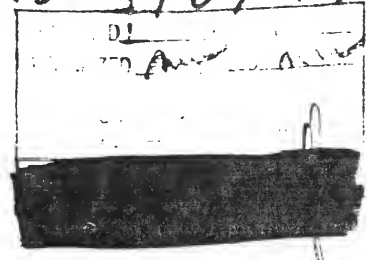

on Saturday, popular time for school-age theatergoers.

"A RAISIN in the Sun." is having its Philadelphia premiere following New Haven.

Poitier, in his first starring role for the Broadway stage, will play the ambitious, restless elder son in a family of strong individualists. With one exception, John Fiedler, who plays the role of a lawyer, the cast is all-Negro.

Featured are Ruby Dee, Claudia McNeil, Louis Gossett and Diana Sands, directed by Lloyd Richards. Ralph Allswang designed the sets for the play being co-produced by Philip Rose and David Cogan.

"THE POKER GAME," which tells of the adjustment of a Jewish daughter-in-law to the Italian-Catholic family life of her husband, is based on the situation and solution of a similar problem lived out in the playwright's own family.

Arriving here from its first performances in Washington, J. Carrol Naish plays Papa Caparuta.

Aline MacMahon, as Mama, has been appearing in Broadway plays after a long time as a familiar face in Hollywood films. Doretta Morrow makes her first non-musical stage appearance as the daughter-in-law.

The setting, by Jac Venza, is Brooklyn, a change of venue by the author from the real-life Mulberry st. East Side background.

The director is Ruth Rawson, also a "Comic Strip" alumna, having directed the earlier effort for producer Forman. As of this moment, she is the only woman director active on the Broadway scene.
